
Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is March 26, 2023**, unless otherwise indicated.

Please note: errors were discovered on the Alpha List under some of the unclassified coding information contained within columns K through O. This appears to have been an administrative error with the Alpha List that occurred in early 2022. The incorrect coding has been restored to what was listed in late 2021. As this was an administrative error related to an Alpha List update, and not a classification plan change, the changes are not listed item by item in this bulletin.

- 1) *Modify the **Insurance Examiner** classification series for the Office of the Commissioner of Insurance to make language updates throughout the classification series, including the identification of specialized terms, and to indicate when progression to the senior level of the series is permitted. - 2) *Modify the **Public Health Educator** classification series to permit the Department of Children and Families to utilize the classification series after the transfer of program responsibilities from the Department of Health Services in 2023.
