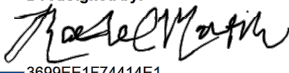
Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is May 21, 2023**, unless otherwise indicated.

NOTE: A new field has been added to the Alpha List, Column P. This field will contain existing Raised Minimum Rates (RMRs) if one exists and has been published. Please also note that RMRs are governed by DPM bulletins and those DPM bulletins remain the official record. The “fields” tab of the Alpha List has been updated to reflect this change to the main tab.

- 1) *Modify* the **Forestry Technician** classification specification to make minor updates within the language of the specification. There are no reallocations necessary for this classification action. Questions may be directed to Abby Butson (608) 264-6112.
- 2) *Modify* the **Forester Technician - Advanced** classification specification to make minor updates within the language of the specification and further clarify that additional agencies may use the classification. There are no reallocations necessary for this classification action. Questions may be directed to Abby Butson (608) 264-6112.
- 3) *Modify* the **Administrator, Division of Technology Services** classification specification to permit a second position for division administrator at a different agency. Reallocations necessary for this classification action will be processed by the affected agency. Questions may be directed to Rachel Martin (608) 267-5165.
- 4) *Change the FLSA category* for **Insurance Financial Examiner - Journey** classification from “*mixed*” to “*nonexempt*” to better reflect the typical categorization under the Fair Labor Standards Act of position in this classification after a close analysis for typical job assignments assigned to positions within the classifications and additional research on similar positions.
