Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is December 3, 2023**, unless otherwise indicated.

- 1) Abolish Tax Resolution Officer classification series for the Department of Revenue and create a new Tax Resolution Officer classification series for the Department of Revenue to update the terminology within the classification specification and provide a level of progression within the books and records resolution officer allocation pattern. This abolishment and re-creation removes the tax specific classification levels (e.g., Tax Resolution Officer Office Audit Object, Tax Resolution Officer Large Case) and replaces them with numbered levels (e.g., Tax Resolution Officer 1, Tax Resolution Officer 5) and is being completed to facilitate the proper placement of staff within the new classification series. Reallocations necessary for this classification action will be processed by the affected shared services regional office and/or non-shared services agency, as applicable, and those entities will provide all required employee notifications. - 2) *Modify* the **Budget and Policy Analyst Division** classification specification to allow for more than one Budget and Policy Analyst Division Advanced in the Division of Employment & Training within the Department of Workforce Development. - 3) Change the Job Group of the Institution Unit Supervisor classification from **007** to **009** to reflect the changes in the classification made in DPM-0612-CC/SC and to more accurately categorize the duties. - 4) Change the DP Code of the **Engineer Supervisor** classification from **98** to **17** to reflect an error in publication of DPM-503-CC/SC. DP code 17 is the correct category, and no change was previously approved. There are no reallocations necessary for this classification action.
