Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is December 1, 2024**, unless otherwise indicated.

- 1) *Create* the **Courts Protection Officer** classification specification for the Department of Administration to provide protective services for the justices of the Wisconsin Supreme Court and other dignitaries as assigned by the Wisconsin Court System.
