Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is December 28, 2025**, unless otherwise indicated.

- 1) *Modify* the **Excise Tax Agent** classification specification series to make general updates to clarify work performed within this classification specification, and to add the duties performed by law enforcement investigators that were previously included as an allocation in a different classification series. Further, *retitle* the **Excise Tax Agent** classification series to **Revenue Special Investigator** classification series to better describe the work performed by the positions now included in the series.
