**Subject:** Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is February 22, 2026**, unless otherwise indicated.

- 1) *Create* the **Unemployment Benefit Specialist - Journey** classification and *modify* the **Unemployment Benefit Specialist** classification series to permit progression to the newly created Journey level and to make general updates to the language in the classification series to reflect this additional level. Further, *change the FLSA* status of the existing four levels of the classification series (i.e., **Unemployment Benefit Specialist, Unemployment Benefit Specialist-Intermediate, Unemployment Benefit Specialist-Senior, and Unemployment Benefit Specialist-Advanced**) from **mixed** to **nonexempt** to better reflect their typical categorization under the FLSA. Reallocations necessary for this classification action will be processed by the affected shared services regional office and/or non-shared services agency, as applicable, and those entities will provide all required employee notifications. - 2) *Modify* the **Corrections Security Director** classification specification to update the classification to add a position for the department and remove unused allocation patterns. - 3) *Modify* the **Court Reporter** classification specification to permit the classification to be used by the Department of Workforce Development and to update the qualifications section.
