Subject: Miscellaneous Classification Plan Changes

Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the **effective date is January 11, 2004**, unless otherwise stated.

1. *Change the FLSA status* of the **Environmental Enforcement Specialist** and **Plant Pest and Disease Specialist** classifications **effective December 14, 2003**, to correct an error in the previous FLSA status of these classifications. No reallocations need to be processed to implement this action. Questions may be directed to Wil Mickelson at (608) 266-0714.
2. *Modify* the **Graphic Reproduction Technician, Graphic Reproduction Technician-Entry** and **Graphic Reproduction Technician-Senior** classification specifications **effective January 11, 2004**, to update the descriptions to better reflect the technology used and the work done by positions within the classification. 3. *Modify* the **Nursing Specialist** classification specification **effective January 11, 2004**, to update the representative positions for the Department of Corrections and the Department of Health and Family Services. No reallocation notices are required. Questions may be directed to Diane Siegler at (608) 267-0408.
4. *Modify and retitle* the **Psychologist Chief-Doctorate, Psychologist Manager-Doctorate**, and **Psychologist Supervisor-Doctorate** and **Doctorate/Management** classification specifications, **effective December 28, 2003**, to remove the reference to "Doctorate." This is being done in order to coincide with the non-represented add-on in Section A of the Compensation Plan and generally update the language to reflect changes in the organizational structure of DOC and/or DHFS. Reallocation notices are not required for this action. Questions may be directed to Kris Chilsen at (608) 266-7569.
5. *Modify* the **Psychologist-Manager** [NOTE: "Doctorate" in the title removed effective 12/28/03] classification specification, **effective January 11, 2004**, to expand the use of the specification to agencies besides DHFS. This modification was made at the request of DOC for an allocation for an Assistant Mental Health Director who will share responsibility for the development, coordination, and administration of mental health services and programming within DOC. 6. *Reassign the pay range* for the **Storage Tank Regulation Chief** classification **effective January 11, 2004**, from 81-03 to 81-02 as a result of organizational changes within the Department of Commerce that moves this position to career executive status.
