Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is February 13, 2011**, unless otherwise stated.

- 1) *Create* the **Disability Determination Program Manager** classification **effective February 13, 2011** to identify positions that serve as Section Chief in the Disability Determination Bureau of the Department of Health Services (DHS). - 2) *Modify* the **Arboretum Project Coordinator 1, 2** classification specification **effective February 13, 2011** to allow use of the classification for more than one position on the UW-Green Bay campus. - 3) *Modify* the **Grants Specialist – Advanced** classification specification **effective February 13, 2011** to remove the Department of Workforce Development Child Care Grant Specialist representative position at the Advanced level.
