Subject: Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is March 10, 2013**, unless otherwise stated.

- 1) *Modify* the **Research Scientist** classification specification for the Department of Health Services to reflect changes to the definition language that better define the demographer work performed in the Epidemiologist allocation.
