
Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is March 9, 2014**, unless otherwise stated.

- 1) *Create* the **Assistant Attorney General- Management** classification level, **effective February 23, 2014**, for the Department of Justice. This classification specification was updated to add the Assistant Attorney General Management classification. No reallocation notices are necessary to accomplish this classification action. - 2) *Create* the **Assistant Director, Museum** classification specification, **effective February 23, 2014**, to describe the single position which functions as the Assistant Director of the Wisconsin State Historical Society Museum. - 9) *Change FLSA Permanent and LTE Categorization* for the **Unclassified Stenographer Constitutional Officer** classification from Mixed to Exempt to align better with duties and responsibilities.
