Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is July 13, 2014**, unless otherwise stated.

The *Job Group Underutilization Project* was implemented which includes revisions to Job groups and EEO-1 categories in order to be consistent with the federal government job group workforce data. 
- 1) *Create* the Natural Resources Customer Service Representative to add the entry level to address the organizational needs and allow for advancement within the classification series. *Modify* the **Natural Resources Customer Service-Senior** classification for the Department of Natural Resources to retitle the classification specification to the class series. No reallocation notices are necessary to accomplish this classification action. Questions may be directed to Dianna McNall at (608) 266-8232.
- 2) *Create* **State Patrol Lieutenant Colonel** classification for the Department of Transportation to better define and clearly delineate the chain of command within the WI State Patrol particularly significant for Incident Command. The affected agency will process any necessary reallocation notices. Questions may be directed to Diane Lund (608) 267-0344.
- 3) *Modify* the **State Patrol Major** classification for the Department of Transportation to account for changing the organizational structure at the Division of State Patrol, to generalize functions assigned to each bureau. No reallocation notices will be necessary to accomplish this classification action. Questions may be directed to Diane Lund (608) 267-0344.
- 4) *Modify* the **University Executive Staff Assistant** classification for the University of Wisconsin System Administration to include positions that provide executive support to the Senior Associate Vice President, Associate Vice President, Chief Audit Executive or Vice Chancellor regardless of Provost status.
