Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is August 10, 2014**, unless otherwise stated.

The *Alphabetical Listing of Classifications* has been revised to indicate that all of the Unclassified Civil Service positions have been assigned to "Job Group" 900. This administrative action is to provide better reporting functionality and match their assignments in wis.jobs.


- 1) *Create* the **Legal Associate Supervisor** classification for the Department of Administration. This class specification has been created to describe positions which are responsible for supervising the activities of Legal Associates within the Department of Administration, Division of Hearings and Appeals. - 2) *Modify* the **Printing Services Supervisor** classification for the Department of Administration. This class specification has been modified to update the first allocation of the Definition language and its corresponding representative position to reflect the new location of this function within the Department of Administration.
