Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the **effective date is November 14, 2004**, unless otherwise stated.

1. *Abolish* the **Assistant Administrator, Executive Budget & Planning** classification, **effective November 14, 2004**, as this will not be used in the future and *create* the **Deputy Administrator, Division of State Executive Budget and Finance** classification due to restructuring of the position's duties such that it now serves as a full-line deputy to the division administrator, rather than as an assistant to the division administrator. 2. *Modify* the **Administrative Program Management Supervisor** classification specification, **effective November 14, 2004**, to add an allocation for new UW System statewide Human Resources Information System (HRIS) management positions. 3. *Modify* the **Bookstore/Museum Gift Shop Assistant Manager** classification specification, **effective November 14, 2004**, to add an allocation for employees managing small bookstores. 4. *Modify* the **Physical Therapy Assistant** classification specification, **effective November 14, 2004**, to add the licensure requirement for positions titled Physical Therapy Assistant. 5. *Modify* the **Revenue Customer Service Representative-Advanced** classification specifications, **effective November 14, 2004**, to add an allocation for positions that handle complex questions regarding electronic filing. 6. *Modify and retitle* the **Chief, Food/Meat Technical Services Section** classification specification, **effective November 14, 2004**, to **Chief, Regulatory and Technical Services** at the request of the Department of Agriculture, Trade and Consumer Protection, to add an allocation for another Chief (Division Compliance).
