Introduction

Wisconsin Stat. § 230.04 (9)(em) requires the Division of Personnel Management (Division) to prepare an annual report on veteran employment in Wisconsin State Government. The Bureau of Equity and Inclusion is charged with completing this report on behalf of the Division. The report covers veteran employment information for state agencies for the fiscal year. The University of Wisconsin System employee data is not included in this report. The State of Wisconsin continued to face challenges due to the COVID-19 pandemic, which affected hiring needs across the state workforce and trends in this report.

The report contains statistics on new state hires and current employees identified as veterans in fiscal year 2022. All data for this report was derived from the Human Capital Management (HCM) PeopleSoft system. The report includes veterans who identify as both disabled and non-disabled and spouses of disabled and deceased veterans. Data collected for New Hires are cumulative during fiscal year 2022 (from July 1, 2021, through June 30, 2022). Disabled veterans are categorized based on the percentage of a service-connected disability. Data collected for current employees are as of June 18, 2022, the last day of the last pay period during fiscal year 2022. The report contains a summary table for all state agencies, and a table for each state agency (except for the State Treasurer Office which consists of just one elected official).

The tables represent two data groups: New Hires and Current Employees. Total new veteran hires and total current veteran employees are categorized by the following employment types: Permanent Classified, Unclassified, Limited-Term, Project, and Seasonal. Each data group is further delineated by veteran status, veteran disability status and disability percentage, spouse of a disabled or deceased veteran status, and disabled spouse of a deceased veteran status.

Employee Types

Permanent Classified Employee: A person who is an employee due to a permanent appointment in a classified civil service position, whether or not the employee has attained permanent status.

Unclassified Employee: A person who is an employee in a position not included in the classified service. Examples are agency heads, division administrators, and attorneys in the State Public Defender's office.

Limited-Term Employee: A person who is an employee in a position that does not permit permanent status in classified service, and regular recruitment and examination procedures are not practical.

Project Employee: A person who is an employee for an approved planned undertaking to meet a timeline for the project completion. Employment conditions do not provide for attainment of permanent status.

Seasonal Employee: A person employed on an intermittent and recurring basis. Permanent position status may occur through successive reinstatements.

Key Findings for Fiscal Year 2022

Current Employees

- Veterans accounted for 7.8% of the state workforce in FY 2022 compared to 8.1% in FY 2021, a decrease of 0.3%.
- Veterans with a disability accounted for 2.1% of all employees in FY 2022, compared to 1.9% in FY 2021, an increase of 0.2%.
- The volume of employees who are spouses of disabled or deceased veterans increased from eight (8) in FY 2021 to 45 in FY 2022.
- The Department of Corrections had the largest number of veteran employees in FY 2021 (1103) and FY 2022 (962).
- The Department of Veterans Affairs had the largest increase in proportion of veteran employees from FY 2021 (9%) to FY 2022 (11%) among agencies with at least 100 employees, an increase of 2%.

New Hires

- Veterans accounted for 5.5% of all new hires in FY 2022 compared to 5.8% in FY 2021, a decrease in percentage of new hires of 0.3%. Although the percentage of new hires decreased, the number of veteran hires increased from FY 2021 (383) to FY 2022 (429).
- Veterans with a disability accounted for 0.7% of all new hires in FY 2022, an increase from 0.6% in FY 2021.
- Spouses of disabled or deceased veterans were less than 0.1% of all new hires in both FY 2021 and FY 2022.
- The Department of Corrections had the largest number of veteran hires in FY 2021 (126) and FY 2022 (103).
- State Fair Park had the largest increase in number of veteran hires from FY 2021 (5) to FY 2022 (26), an increase of 21 hires.
- The Department of Veterans Affairs had the largest increase in the proportion of veteran hires from FY 2021 (8.5%) to FY 2022 (11.5%) among agencies with at least 100 hires, an increase of 3%.

Strategic Considerations

Across all industries, veterans are a source of qualified, committed job candidates with transferable skills that are valuable to the state workforce. This report provides statistical information for agencies to consider as they plan to increase their recruitment and retention of veterans and their spouses. State agencies are also encouraged to evaluate the agency's culture and work to advance an inclusive culture that recognizes and appreciates the veterans' strengths and contributions to the state workforce.
