Introduction

Wisconsin Stat. [§ 230.04 \(9\)\(em\)](#) requires the Division of Personnel Management to prepare an annual report on veteran employment in Wisconsin State Government. The Bureau of Equity and Inclusion is charged with completing this report on behalf of the Division. The report covers veteran employment information for state agencies for the fiscal year (FY). University of Wisconsin System employee data is not included in this report since legislation implemented in July 2015 removed them from the classified and unclassified service.

Description of Report

The report contains statistics on new state hires and current employees who are veterans in FY 2025. All data for this report was derived from the Human Capital Management (HCM) module of the PeopleSoft system. The report highlights veteran employment and includes all veterans, including veterans with service-connected disabilities. Data collected for new hires is cumulative during FY 2025 (from July 1, 2024, through June 30, 2025). Data collected for current employees is effective as of June 30, 2025, the last day of the fiscal year. The report contains a summary table for all state agencies and an individual table for each state agency (except for the State Treasurer's Office, which consists of one elected official).

The tables represent two data groups: New Hires and Current Employees. Total new veteran hires and total current veteran employees are categorized by the following employment types: permanent classified, unclassified, limited-term, project, and seasonal employment. Additionally, each data group is further delineated by veteran status (i.e. Total Veteran Hires and Total Current Veteran Employees in the tables below).

Employee Types

Permanent Classified Employee: A person who is an employee due to a permanent appointment in the classified civil service, whether or not the employee has attained permanent status. Note: Permanent classified employees can be in permanent or project positions.

Unclassified Employee: A person who is an employee in a position not included in the classified service. Examples are agency heads, division administrators, and attorneys in the State Public Defender's office.

Project Employee: A person who is an employee in a project position under conditions of employment that do not provide for the attainment of permanent status.

Limited-Term Employee (LTE): A person who is an employee in a position that does not permit permanent status in classified service, and regular recruitment and selection procedures are not practical.

Seasonal Employee: A person employed on an intermittent and recurring basis for at least 600 hours each year. Permanent status may occur through successive reinstatements.

The following employee types are grouped for the reporting tables presented later in the report:

- **Total Permanent (labeled Permanent in the tables below):** Includes permanent classified employees in permanent positions and permanent classified employees in project positions.
- **Total Unclassified (labeled Unclassified in the tables below):** Consists of all unclassified employees including unclassified employees in temporary positions.

Key Findings for Fiscal Year 2025

New Hires

- The percentage of veteran new hires decreased by 0.7%. Veterans accounted for 6.0% of all new hires in FY 2025, compared to 6.7% in FY 2024.
- Veterans with a service-connected disability accounted for 1.8% of all new hires in FY 2025, an increase from 1.5% in FY 2024.
- The Department of Corrections had the largest number of veteran hires in FY 2024 (236) and FY 2025 (164).
- The Department of Veterans Affairs had the largest increase in the number of veterans hired from FY 2024 (20) to FY 2025 (26), with an increase of 6 hires.
- The Department of Financial Institutions had the largest increase in the proportion of veteran hires from FY 2024 (3.1%) to FY 2025 (9.1%), an increase of 6%.

Current Employees

- Veterans accounted for 7.4% of the state workforce in FY 2025, compared to 7.6% in FY 2024, a decrease of 0.2%. The total number of veteran employees also decreased from FY 2024 (2,731) to FY 2025 (2,681).
 - The total proportion of veterans employed by the state in FY 2025 continues to exceed the proportion of veterans in the nation's workforce (5.0% in 2025) and Wisconsin's overall workforce (4.6% in 2024).¹
- Employment of veterans with a disability increased to 2.3%, up from 2.2% of all employees in FY 2024.
- The Department of Corrections had the largest number of veteran employees in FY 2024 (999) and FY 2025 (972).
- The Department of Safety and Professional Services had the largest increase in the proportion of veteran employees from FY 2024 (4.9%) to FY 2025 (6.2%) among agencies with at least 100 employees, an increase of 1.3%.
- In FY 25, the Department of Military Affairs had the largest percentage of veteran employees (33.5%) among agencies with at least 100 employees.

Strategic Considerations

Across all industries, veterans are a source of qualified, committed job candidates with transferable skills that are valuable to the state workforce. This report provides statistical information for agencies to consider as they plan to increase recruitment and retention of veterans. DPM reviews and reevaluates reporting methodology periodically to provide the most accurate information available.

State agencies are also encouraged to evaluate their culture and work to advance an inclusive environment that recognizes and appreciates the strength, commitment, and contributions of veterans to the state workforce.
