Introduction

Wisconsin Stat. [§ 230.04 \(9\)\(em\)](#) requires the Division of Personnel Management to prepare an annual report on veteran employment in Wisconsin State Government. The Bureau of Equity and Inclusion is charged with completing this report on behalf of the Division. The report covers veteran employment information for state agencies for the fiscal year. University of Wisconsin system employee data is not included in this report.

Description of Report

The report contains statistics on new state hires and current employees identified as veterans in the fiscal year 2023. All data for this report was derived from the Human Capital Management (HCM) module of the PeopleSoft system. The report includes veterans who identify as disabled and non-disabled and spouses of disabled and deceased veterans. Data collected for new hires are cumulative during the fiscal year 2023 (from July 1, 2022, through June 30, 2023). Disabled veterans are categorized based on the percentage their service-connected disability. Data collected for current employees is as of June 30, 2023, the last day of the fiscal year. The report contains a summary table for all state agencies and an individual table for each state agency (with the exception of the State Treasurer's Office, which consists of just one elected official).

The tables represent two data groups: New Hires and Current Employees. Total new veteran hires and total current veteran employees are categorized by the following employment types: permanent classified, unclassified, limited-term, project, and seasonal employment. Additionally, each data group is further delineated by veteran status, veteran disability status and disability percentage, spouse of a disabled or deceased veteran status, and disabled spouse of a deceased veteran status.

Employee Types

Permanent Classified Employee: A person who is an employee due to a permanent appointment in the classified civil service, regardless of whether or not the employee has attained permanent status. Note permanent classified employees can be in permanent or project positions.

Unclassified Employee: A person who is an employee in a position not included in the classified service. Examples are agency heads, division administrators, and attorneys in the State Public Defender's office.

Project Employee: A person who is an employee in a project position under conditions of employment that do not provide for the attainment of permanent status.

Limited-Term Employee (LTE): A person who is an employee in a position that does not permit permanent status in classified service, and regular recruitment and examination procedures are not practical.

Seasonal Employee: A person employed on an intermittent and recurring basis for at least 600 hours each year. Permanent status may occur through successive reinstatements.

The following employee types are grouped together for the reporting tables presented later in the report:

- Total Permanent: Includes permanent classified employees in permanent positions and permanent classified employees in project positions.
- Total Unclassified: Consists of all unclassified employees including unclassified employees in temporary (LTE) positions.

Key Findings for Fiscal Year 2023

Current Employees

- Veterans comprised 7.5% of the state workforce in FY 2023, compared to 7.8% in FY 2022, a decrease of 0.3%. The total number of veteran employees also decreased from FY 2022 (2,646) to FY 2023 (2,588).
 - Despite the decrease in the proportion of and the total number of veterans employed by the state in FY 2023, veteran employment continues to exceed the proportion of veterans in the nation's workforce (5.36 percent in 2022) and Wisconsin's overall workforce (4.5% in 2022).¹
- Employment of veterans with a disability remained stable, accounting for 2.1% of all employees in FY 2023 and FY2022.
- The number of employees who are the spouse of a veteran with a disability, the spouse of a deceased veteran with a disability, or the spouse of a deceased veteran increased from 45 in FY 2022 to 63 in FY 2023.
- The Department of Corrections had the largest number of veteran employees in FY 2022 (962) and FY 2023 (916).
- The Department of Employee Trust Funds had the largest increase in the proportion of veteran employees from FY 2022 (5.8%) to FY 2023 (6.6%) among agencies with at least 100 employees, an increase of 0.8%.
- At 34.2%, the Department of Military Affairs had had the largest percentage of veteran employees among agencies with at least 100 employees.

New Hires

- The percentage of veteran new hires increased by .04%. Veterans accounted for 5.9% of all new hires in FY 2023 compared to 5.5% in FY 2022. While the percentage of veteran hires increased, the number of veterans hired decreased from FY 2022 (429) to FY 2023 (422).
- Veterans with a disability accounted for 0.5% of all new hires in FY 2023, a decrease from 0.7% in FY 2022.
- No spouses of disabled or deceased veterans were hired in FY 2023, a decrease from 0.03% of all new hires FY 2022.
- The Department of Corrections had the largest number of veteran hires in FY 2022 (103) and FY 2023 (138). The Department of Corrections also had the largest increase in the number of veterans hired from FY 2022 to FY 2023, with an increase of 35 hires.
- The Department of Veterans Affairs had the largest increase in the proportion of veteran hires from FY 2022 (11.5%) to FY 2023 (17.3%) among agencies with at least 100 hires, an increase of 5.8%.

Strategic Considerations

Across all industries, veterans are a source of qualified, committed job candidates with transferable skills that are valuable to the state workforce. This report provides statistical information for agencies to consider as they plan to increase their recruitment and retention of veterans and their spouses. DPM reviews and reevaluates reporting methodology periodically to provide the most accurate information available.

State agencies are also encouraged to evaluate its culture and work to advance an inclusive environment that recognizes and appreciates veterans' strengths and contributions to the state workforce.
