WHAT IS THE PROCEDURE?

- Complete the SAAIP application on Wisc.Jobs
- Attach your resume and your Student Status Verification form completed by your school's advisor or Registrar's Office. The application process is considered incomplete and your application will be ineligible without these two documents.
- Applications will be reviewed for eligibility and to verify that the required information is completed.
- In early March, the SAAIP
 Coordinator will begin referring eligible candidates to participating agencies.
- Participating agencies will contact candidates for interviews in the following weeks.

WHERE WOULD I WORK?

Most of the intern positions are in the Madison area. There are a limited number of internships in Milwaukee, Green Bay, and other outlying areas across the state.
