STATE OF WISCONSIN CLASSIFICATION SPECIFICATION

ADMISSIONS AND DISCHARGES SUPERVISOR

I. INTRODUCTION

A. PURPOSE OF THIS CLASSIFICATION SPECIFICATION

This classification specification is the basic authority [under Wis. Admin. Code ER 2.04] for making classification decisions relative to present and future professional supervisory positions located within the Department of Veterans Affairs which function as the Admissions and Discharges Supervisor within the Division of Veterans Home. This classification specification will not specifically identify every eventuality or combination of duties and responsibilities of positions that currently exist, or those that result from changing program emphasis in the future. Rather, it is designed to serve as a framework for classification decision- making in this occupational area.

B. INCLUSIONS

This one-position classification specification encompasses the professional supervisory position located within the Department of Veterans Affairs, Division of Wisconsin Veterans Home, which functions as the Admissions and Discharges Supervisor. The position allocated to this classification supervises and directs the program for admission eligibility determination for veterans, their spouses, and surviving spouses based on medical criteria and state and federal rules and regulations, including the liquidation of all types of member assets and disbursement of the estate upon death or discharge; and meets the statutory definition of supervisory as defined in Wis. Stats. 111.81(19). The position in this classification is also responsible for program planning, policy and procedure input and development, budget development, and supervision of staff within their respective program area.

C. EXCLUSIONS

Excluded from this series are the following types of positions: 1. Positions located outside of the Department of Veterans Affairs or positions which do not function as the Admissions and Discharges Supervisor. 2. Positions which do not meet the statutory definition of supervisory as defined in Wis. Stats. 111.81(19). 3. All other positions which are more appropriately identified by other classification specifications.

D. ENTRANCE INTO AND PROGRESSION THROUGH THIS SERIES

Employes typically enter positions within this classification series by competitive examination.

II. DEFINITION ADMISSIONS AND DISCHARGES SUPERVISOR

The position allocated to this classification functions as the Admissions and Discharges Supervisor, located within the Division of Wisconsin Veterans Home in the Department of Veterans Affairs. This position supervises and directs the program for admission eligibility determination for veterans, their spouses, and surviving spouses based on medical criteria and state and federal rules and regulations, including liquidation of all types of member assets and disbursement of the estate upon death or discharge.

III. QUALIFICATIONS

The qualifications required for this position will be determined at the time of recruitment. Such determinations will be made based on an analysis of the goals and worker activities performed and by an identification of the education, training, work, or other life experience which would provide reasonable assurance that the knowledge and skills required upon appointment have been acquired.
