Subject: Miscellaneous Classification Plan Changes and Implementation of the Identification Technician Survey


Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is October 28, 2018.**

- 1) *Modify* the **Corrections Security Director** classification to add an allocation that oversees all women's correctional center security functions, and to make general updates throughout the specification. Reallocations are not necessary for this classification action. Questions may be directed to Peter Flood at (608) 266-8149.
- 2) *Modify* the **Electronics Agency Technician** classification series to update the definition language at the entry level and to update the representative positions. Reallocations are not necessary for this classification action. Questions may be directed to Peter Flood (608) 266-8149.
- 3) *Modify* the **Fingerprint and Footwear Examiner** classification series to better reflect the work performed by positions within the classifications and as a part of the implementation of the Identification Technician classification personnel management survey. Reallocations are not necessary for this classification action. Questions may be directed to Peter Flood at (608) 266-8149.
- 4) *Modify* the **Trust Funds Director** classification to add an additional allocation to include the Deputy Director of the Office of Enterprise Initiatives and to update the working title for the Strategic Health Policy advisor. Reallocations are not necessary for this classification action. Questions may be directed to Rachel Martin at (608) 267-5165.
- 5) *Modify* the **Identification Technician** classification series to make general updates throughout the classification, *retitle* the classification to **Fingerprint Technician** classification series, and *reassign the pay range* of the Fingerprint Technician-Entry from 06-10 to 06-13, the Fingerprint Technician-Senior from 06-13 to 06-14, and the Fingerprint Technician-Advanced from 06-14 to 06-15 as part of the implementation of the Identification Technician personnel management survey for the Department of Justice. Employees reallocated will receive an increase of 8% of the minimum of the new pay range or be paid at the new pay range minimum, whichever is greater.
