- 3) Modify the Rehabilitation Specialist for the Blind classification series to update the organizational reference to the Division of Public Health, allow for competition or reclassification to the Advanced level, and add assistive technology to the list of acceptable certifications at the Advanced level. - 4) Modify and reassign the pay range of the Executive Director, Child Abuse and Neglect Prevention Board classification to update the description of the duties assigned to this position.
