Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is November 20, 2022**, unless otherwise indicated.

- 1) *Abolish* the **Social Worker – Corrections** classification series and reallocate incumbents to the Social Worker classification series to complete the broadbanding of this occupational area. Reallocations necessary for this classification action will be processed by DPM Central Office but affected regional human resources offices will provide all required notifications. - 2) *Reassign the Pay Range* of the **Offender Classification Specialist** from **12-07** to **12-64**, **Offender Classification Specialist-Senior** from **12-08** to **12-63**, and the **Offender Classification Specialist-Advanced** from **12-09** to **12-63** to broadband this classification series. Further, *change the FLSA status* of **Offender Classification Specialist** from **exempt** to **nonexempt** to more accurately reflect work assignments. Reallocations necessary for this classification action will be processed by DPM Central Office but affected regional human resources offices will provide all required notifications.
