- Modify the Deputy Administrator, Department of Health and Family Services classification specification, <u>effective May 15, 2005</u> to reflect positions allocated to this classification based on the department reorganization. - 5) *Modify* the **Recreation Leader** (**A**,**B**) classification specification, <u>effective May 15, 2005</u>, to reflect the modification of the description of work performed within the Department of Corrections. - 6) *Modify* the **Revenue Agent** classification series specification, <u>effective May 15, 2005</u> to reflect modifications to duties performed under the allocations at the revenue agent and revenue agent 3 levels within the department.
