- 1) Abolish the Veterans Assistance Program Director and the Veterans Employment and Training Supervisor classifications and create the Veterans Program Supervisor, effective

 September 3, 2006, in order to simplify the classification system by reallocating the single position classifications into a broader classification describing professional supervisory positions located at the Department of Veterans Affairs central office which are responsible for supervising the activities of specialized statewide veterans programs. - 3) Modify the Nursing Administrator classification specification, effective September 3, 2006, to include Section Chief positions in the Division of Health Care Financing, Bureau of Program Integrity. - 4) **Modify** the **Nursing Supervisor** classification specification, **effective September 3, 2006**, to remove an allocation for Nursing Supervisors in the Department of Health & Family Services, Division of Health Care Financing.
