Pursuant to s. 230.09(2)(am), Wis. Stats., the Director of the Office of State Employment Relations (OSER) shall "... establish, modify or abolish classifications as the needs of the service require." The Director has delegated authority to create classifications used exclusively by the University of Wisconsin Hospital and Clinics Board (UWHC) to the Board. In accordance with the collective bargaining agreement between the UWHC and the Wisconsin State Employees Union, the effects of classification changes including the compensation structure must be negotiated between the parties. These parties have recently successfully completed negotiation of the compensation structure and related matters and the Director of OSER is publishing the new classifications associated with that agreement. Regardless of the actual notification date to employees, the <u>effective date is reflected within the text noted below</u>.

Publish notice, on behalf of the University of Wisconsin Hospital and Clinics (UWHC), of the abolishment, creation and/or modification of the classification structure for positions employed by the UWHC Board, as negotiated between the UWHC and the Wisconsin State Employees Union, <u>effective March 4 and March 6, 2008</u>. Use of these classifications is limited exclusively to the UWHC and the specifications will not be posted on the Office of State Employment Relations website, although the titles will appear in a section of the Alphabetical Listing of Classifications devoted exclusively to UWHC classification listings. - 1) Effective March 4, 2008, the classification of UWHC Ophthalmic Assistant was eliminated and replaced with the UWHC Ophthalmic Technician classification. The UWHC Ophthalmic Technician classification has three levels Associate, Objective and Senior. The Associate level reflects the duties of the former UWHC Ophthalmic Assistant Objective level.
- 2) Effective March 6, 2008, the classification of UWHC Security Office was modified to add the levels of UWHC Security Officer Objective and UWHC Security Officer Senior.
