Miscellaneous Classification Plan Changes

Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is June 6, 2010,** unless otherwise stated.

- 1) Modify the Client Rights Specialist classification specification, effective June 6 2010, to incorporate positions in the Department of Children and Families' Bureau of Milwaukee Child Welfare that protect client rights by investigating and resolving client complaints and allegations of violations of the state child welfare statutes. - 2) Modify the Elevator Constructor classification specification, <u>effective June 6, 2010</u>, to recognize the need for the employee to be licensed under Comm 5.992, Wis. Adm. Code. - 3) Modify the Revenue Agent Supervisor classification specification, effective June 6, 2010, to add two types of tax accounts that supervised employees review. - 4) Modify the Revenue Program Supervisor classification specification, effective June 6, 2010, to remove the Document Processing Supervisor and Income Tax Adjustment Unit Supervisor allocations; add allocations in the Customer Service Bureau and modify other allocations.
