Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is September 12, 2010,** unless otherwise stated.

- Abolish the Deputy Administrator, Department of Health & Family Services classification and create the Deputy Administrator, Department of Health Services classification, effective September 12, 2010, to accommodate the renaming of the Department of Health and Family Services to the Department of Health Services and to remove the specific division designations from the specification. Reallocation notices necessary to implement this classification action will be processed by the agency. Questions may be directed to Pat Waterman at (608) 266-8149.
- 2) Abolish the Justice Record Check Supervisor classification and create the Justice Records Supervisor classification, effective September 12, 2010, to change the title and remove the restriction to utilize this classification for only positions within the Records Check Unit and to allow use for other legislatively mandated criminal records programs at the Department of Justice. Reallocation notices necessary to implement this classification action will be processed by the agency. Questions may be directed to Pat Waterman at (608) 266-8149.
- 3) Create the Companion Animal Inspector classification, effective September 12, 2010, as a result of Assembly Bill 260 which requires certain persons who sell dogs or operate animal shelters or animal control facilities to be licensed by the Department of Agriculture, Trade and Consumer Protection. No reallocation notices are necessary to implement this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 4) Create the **Thermal System Insulation Inspector** classification, <u>effective September 12, 2010</u>, to describe positions at the Department of Commerce, Division of Safety and Buildings, which perform inspections of thermal system insulation as required by Wisconsin Act 16. - Modify the Employment Security Assistant (ESA) classification specification, <u>effective September 12, 2010</u>, to update the name of the Department of Industry, Labor and Human Relations and programs to the Department of Workforce Development and divisions and to add an allocation for a Staff Development Coordinator at the ESA 4 level. Reallocation notices necessary to implement this classification action will be processed by the agency. Questions may be directed to Pat Waterman at (608) 266-8149.
- 6) *Modify* the **Health Care Manager** classification specification, <u>effective September 12, 2010</u>, to include an allocation for positions that function as Associate Administrator. 7) Modify the **Health Information Technician** classification series, <u>effective September 12, 2010</u>, to accommodate those positions in agencies such as the Department of Corrections that do not do medical coding, but have full responsibility for the remainder of the tasks listed within the classification specification.
