Subject: Miscellaneous Classification Plan Changes

Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is November 7**, 2010, unless otherwise stated.

- Abolish the Animal Sciences Meat Technician, Cereal Chemist, Cytopreparation Technician, Glass Technician, Herd Improvement Technician, Liquid Helium/Nitrogen Technician, Meat and Animal Procurement Technician, Ocular Photography Technician, PSL Ultra High Vacuum Specialist, Radiobiology Technician, and X-Ray Lithography Technician classifications <u>effective November 7</u>, <u>2010</u>. The classifications are vacant and are not expected to be used in the future. No reallocation notices are necessary for this classification. - 2) Abolish the Corrections Food Service Leader 1 classification <u>effective November 7, 2010</u>, for the Departments of Corrections and Health Services because positions are no longer correctly classified at this level and the classification level is not expected to be used in the future. Reallocation notices will need to be processed by the agency for this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 3) *Abolish* the **Power Plant Supervisor** classification <u>effective October 10, 2010</u>, for the University of Wisconsin (UW) Madison as part of the changes resulting from the renovation of the Charter Street power plant with the addition of biomass fuel technology and the need for the UW-Madison supervisors to rotate/work in both the Charter Street and Walnut Street power plants to manage the 24/7 operation of the plant, the supervisors in this classification are no longer properly classified. Reallocation notices will need to be processed by the University for this classification action. Questions may be directed to Pat Waterman at (608) 266-8149
- 4) Modify the Corrections Food Service Leader 2, 3 and 4 classification series <u>effective November 7, 2010</u>, for the Departments of Corrections and Health Services to include an allocation identifying positions at the Sand Ridge Secure Treatment Center and the Wisconsin Resource Center in the Corrections Food Service Leader 2 classification, exclude other positions that deal with food rather than those that do not, update the name of the Division of Community Corrections to the Division of Adult Institutions, remove an allocation at the 3 level, and make various other minor updates. Any reallocation notices necessary for this classification action will be processed by the agency. Questions may be directed to Pat Waterman at (608) 266-8149.
- 5) *Modify* the **Crafts Worker Supervisor** classification specification <u>effective November 7, 2010</u>, to update the specification to current formatting and the qualifications necessary for hire into the classification. No reallocation notices are necessary for this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 6) *Modify* the **Power Plant Superintendent** classification specification <u>effective October 10, 2010</u>, to identify changes resulting from the renovation of the Charter Street power plant with the addition of biomass fuel technology and the need for the UW-Madison supervisors to rotate/work in both the Charter Street and Walnut Street power plants to manage the 24/7 operation of the plant. Any reallocation notices necessary for this classification action will be processed by the University. Questions may be directed to Pat Waterman at (608) 266-8149.
