Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is March 11, 2012,** unless otherwise stated.

- 1) Abolish the Accountant (UTF Systems) classification <u>effective March 11, 2012</u>, for the Department of Workforce Development, because the duties were moved to a different classification and this classification will no longer be used. No reallocation notices are necessary to accomplish this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 2) Abolish the Arboretum Project Coordinator 1 and 2 classification series and Create the Arboretum Project Coordinator classification effective March 11, 2012, for the University of Wisconsin, collapsing the two level classification into one level to address the higher level work and responsibility of the UW-Green Bay positions and to add an allocation for the Arboretum Ranger at the UW-Madison Arboretum. - 3) Create the Unemployment Benefit Analyst 2 classification level, effective March 11, 2012, for the Department of Workforce Development, to provide an avenue for employees to learn the duties, observe and participate on a scaled back level as a UBA 2 to gain the experience needed to be reclassified to the UBA 3 objective level. No reallocation notices are necessary to accomplish this classification action. Questions may be directed to Pat Waterman at (608) 266-8149.
- 4) Modify the Unemployment Benefit Analyst 3 and 4 classification specification effective March 11, 2012, for the Department of Workforce Development, to modify the progression language and better clarify the differences in duties between the 3 and 4 levels.
