Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is May 6, 2012,** unless otherwise stated.

- 1) *Modify* the **Psychiatrist** classification specification to add language updating the licensing and residency requirement in the functional areas. No reallocation notices are necessary to accomplish this classification action. Questions may be directed to Dianna McNall at (608) 266-8232.
- 2) Modify and Reassign the Pay Ranges for the **Trust Funds Assistant 1, 2, 3** classification series as a result of the Personnel Management Mini Survey, in order to reflect an expansion of the complexity of the duties and reassign the pay ranges to line up with comparable classes. The Department of Employee Trust Funds will process reallocation notices regarding the pay range reassignments including the applicable range adjustment increases. - 3) Modify the Veterans Benefits Specialist 1 and 2 classification series to allow the use of the classification by other agencies or UW campuses outside of Veteran Affairs. - 4) Change DP Unit Code for the **State Patrol Trooper** and **State Patrol Inspector** classification specifications for the Department of Transportation by creating a new data processing (DP) unit code for the two classifications which are assigned to the new "public safety" bargaining unit.
