Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is April 7, 2013**, unless otherwise stated.

- 1) Abolish the State Patrol Trooper-Confidential classification specification for the Department of Transportation. This classification is vacant and not expected to be used in the future.
