Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is August 11, 2013,** unless otherwise stated.

- 1. Abolish the Initial Assessment Specialist-Advanced, effective July 28, 2013, and Modify the Initial Assessment Specialist classification for the Department of Children and Families, Bureau of Milwaukee Child Welfare, to allow for further reorganization and planning in the Bureau. No reallocation notices will be necessary to accomplish this classification action. Questions may be directed to Dianna McNall at (608) 266-8232.
- 2. Abolish the **Petroleum System Specialist** classification series for the Department of Safety and Professional Services as a result of the transfer of the program area to the Department of Agriculture, Trade and Consumer Protection. - 3. Abolish the Weights & Measures Inspector classification series for the Department of Agriculture, Trade and Consumer Protection as a result of the transfer of the Petroleum System Specialist program area to DATCP to merge responsibilities that will create efficiencies within the program area. Abolish the Petroleum System District Supervisor classification and Create the Weights & Measures Petroleum System Supervisor classification for the Department of Safety and Professional Services to describe the job duties of the DATCP Weights & Measures program that were merged with the Petroleum System program. - 5. Create the Weights & Measures Petroleum System Specialist classification series for the Department of Agriculture, Trade and Consumer Protection which will merge the job duties of the Weights and Measures staff and Petroleum System Specialist to create efficiencies in work across the state due to the close relationship of the program functions. - 6. Modify the Consumer Complaint Supervisor classification for the Department of Agriculture, Trade and Consumer Protection to update the definition language and omit the representative positions that are no longer relevant. - 7. Modify the Consumer Protection Supervisor classification for the Department of Agriculture, Trade and Consumer Protection, Department of Justice and the Department of Transportation. This action will update the definition language to include mediation and remove the allocation pertaining to the Weights and Measures. - 8. *Modify* the Revenue Administrative Manager classification for the Department of Revenue to update the Section Chief Allocations and Assessor 3 reference in the qualification section. No reallocation
