Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is October 6, 2013,** unless otherwise stated.

- 1) Abolish the Equal Rights Supervisor and the Worker's Compensation Program Supervisor classifications and Modify Workforce Development Program Manager classification series to include section chiefs that do not have subordinate level supervisors reporting to them. The definition language for Workforce Development Program Manager was updated to include represented positions, correct division names, delete references to programs that are no longer relevant, and allow inclusion positions previously classified as Worker's Compensation Program Supervisor or Equal Rights Supervisor. - 2) Modify the Revenue Program Supervisor classification for the Department of Revenue to update the descriptions of the allocations within this classification and create more distinct allocations for the Unclaimed Property Section and Refund Research and Return Services Section.
