
Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is September 7, 2014**, unless otherwise stated.

- 1) *Modify* the **Aviation Consultant** classification for the Department of Transportation. This class specification has been modified in order to better define the duties and responsibilities of this classification. Affected agencies will process any necessary reallocations. - 2) *Modify* the **Vital Records Program Specialist** classification for the Department of Health Services. This class specification has been modified due to Vital Records implementing a statewide IT system for all business partners around the state that will replace mailing and manual data entry. The change in the IT system requires multiple positions to be able to work around the state with all business entities to maintain an acceptable system and can no longer be completed by one position.
