Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the effective date is October 5, 2014, unless otherwise stated.

- 1) Abolish the Worker's Compensation Specialist 1, 2, 3 classification series and create the Worker's Compensation Specialist classification series for the Department of Workforce Development as part of broadbanding and revisions to definitions and progression language. Necessary reallocations for this classification action will be processed by the affected agency. Questions may be directed to Peter Flood at (608) 266-8149.
- 2) Create the Public Defender Investigator Supervisor classification for the Office of the Wisconsin State Public Defender to create a singular position that is responsible for supervising Public Defender Investigators headquartered in the Milwaukee Trial Office and for coordinating the services provided by the Public Defender Investigators statewide. - 3) Modify the Surveyor classification series to update the definition language in order to combine both of the advanced levels into one level and retitling that level to Surveyor Advanced in order better reflect job duties and business needs. The Surveyor Advanced level has been reassigned to pay range 14-13. The Survey-Advanced 2 level has been abolished. Any necessary reallocations for this classification action will be processed by the affected agencies. Questions may be directed to Diane Lund at (608) 267-0344.
- 4) Reassign Pay Range for the Worker's Compensation Rehabilitation Specialist from 12-06 to 12-63. This pay range reassignment is the result of the broadbanding of this classification.
