Subject: Classification Plan Changes Resulting from

Negotiated Pay Range Reassignments for WSEU **Blue Collar** and **Law Enforcement** Bargaining Units and for Administrative Purposes for Classification Simplification and Specification Modification for the **Technical** and **Professional**

Social Services Bargaining Units.

Pursuant to s. 230.09, Stats., the Secretary of the Department of Employment Relations (DER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the <u>effective date is June 1, 2003</u>, unless otherwise stated.

- 1. As part of contract negotiations, the <u>pay ranges are reassigned</u> for the classifications of: Auto Equipment Technician-Entry, Custodian, Farm Laborer, Food Service Assistant 1, Laboratory Helper, Laundry Worker, Motor Vehicle Operator-Light, Seamstress/Seamer 1, Shipping and Mailing Clerk 1, and Stock Clerk. The Department of Administration Central Payroll and University of Wisconsin Central Payroll will automate these transactions.
- 2. As part of contract negotiations, the <u>pay range is reassigned</u> for the **Police Communications Operator** effective <u>May 18, 2003</u>. The Department of Administration Central Payroll and University of Wisconsin Central Payroll will automate these transactions.
- 3. The following changes result from DER collapsing and modifying classifications. The modifications eliminate unused classifications and update old classification specification language. Agencies should process manual Reallocation Notices for employees impacted by the following transactions.
 - A. Classifications in the WSEU-Technical bargaining unit affected by the modifications are the Cytopreparation Technician series, Electroencephalograph Technician series, Environmental Lab Technician series, Exhibits Technician series, Histology Technician series, Licensed Practical Nurse series, Microfilm Technician series, Ophthalmic Assistant series, Phlebotomist series, Physical Therapy Assistant series, and the Soil Technician series.
 - B. The classification in the Professional Social Services bargaining unit is the **Employment and Training Analyst** series.

NOTE: Following are corrections for previous contract change bulletins effective May 18, 2003:

1. MRS-SC-153, Blue Collar Unit, page 5 under "Reassign Pay Range" for the *Automotive Equipment Technician-Entry*, the EEO Cat. should be **8** instead of 5 for both the Old and New.

2. MRS-SC-154, Administrative Support Unit, page one in chart, *Technical Typist-Senior* should be in S/R **02-09** instead of 02-08.

- 3. MRS-SC-154, Administrative Support Unit, page two, number 2), second paragraph, the *Medical Program Assistant* and *Staff Assistant* classifications should read "...to recognize the unique nature of **positions in a clinical setting within the UW system**..." instead of "...to recognize the unique nature of medical school positions ..."
- 4. MRS-SC-155, Professional Social Services Unit, page 3, under "Class Title Change and Modify to Automatic Progression Series and Pay Range Reassignment" the old titles should be **Vocational Rehab Counselor** and **Vocational Rehab Counselor-Senior** instead of Vocational Rehab Counselor-Entry and Vocational Rehab Counselor-Objective.
- 5. MRS-SC-158, WPEC Broadbanding and Class Collapsing Study, page 7, under "Create" the Job Group Code for *Health Care Rate Analyst* should be **016** instead of 019.
- 6. MRS-SC-158, WPEC Broadbanding and Class Collapsing Study, page 22, under "Reassign Pay Range and Class Code", the FLSA Code for *Revenue Agent 4* should be **E**[xempt] instead of N[onexempt] for the old and new.
