Pursuant to s. 230.09, Wis. Stats., the Secretary of the Department of Employment Relations (DER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the **effective date is June 15, 2003**, unless otherwise stated.

As part of contract negotiations, the pay range assignments of three classification series in the Technical Bargaining Unit have been reassigned. The classifications are Plumbing Consultant 1 and 2, Plumbing Plan Reviewer 1 and 2, and Private Sewage Plan Reviewer 1 and 2. As part of class plan administration, these classification are being collapsed to Plumbing Consultant, Plumbing Plan Reviewer, and Private Sewage Plan Reviewer.

The Department of Commerce will process manual reallocations to implement the class collapsing for all affected employees. Questions may be directed to Tom Sandine at (608) 267-5166.

**Notification to Agencies**: There have been numerous classification structure changes published in Bulletins MRS-SC-151, 152, 153, 154, 155, 156, 157, 158, 159, 160, 161, and 162. As soon as administratively possible, formal classification delegation agreements will be modified to reflect those changes. In the meantime, agencies are delegated authority from the DER to continue operating under the existing agreement, converting the former classification titles to the replacement titles.
