Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the <u>effective date is February 6, 2005</u>, unless otherwise stated.

- 1) Abolish the Food Scientist and Food Scientist-Senior classifications, <u>effective February 6, 2005</u>, as they are no longer being used and *modify* the Food Scientist-Advanced classification specification to include the meat position, formerly, the senior level for the Department of Agriculture, Trade and Consumer Protection. - 5) Modify the Revenue Management Supervisor classification specification, <u>effective</u> <u>February 6, 2005</u>, to indicate changes in allocations at the Department of Revenue as one unit was eliminated, two units combined and three new positions created.
